TERMS OF SALES

Financial charges (bank charges linked to the exchange rate, bank commission for payment transactions carried out outside the territory of issue of the bank card, other bank commissions, etc.) possibly linked payments by credit card will remain the responsibility of the customer.

The agreement of the central bank card network makes the order validated by the customer effective on the website. In the event that the central bank card network refuses, our company reserves the right to cancel the reservation.

During the payment transaction, the customer is automatically connected to the server of the processing center regulations. Bank data is protected by encryption, they do not pass through the rental company's systems and it is therefore not kept.

The prices indicated are modifiable at any time without notice, knowing that the articles will be invoiced on the price in force when the order is registered.

The customer can pay their reservation directly online, choosing from the following acronyms CB, VISA, EC (Eurocard) or MC (Mastercard) and entering the 16 numbers and the expiration date of his card as well as the cryptogram composed of 3 digits on the back of the card.

The order thus validated by the customer on the website will only be effective when the central card network banks will have given their consent

The data relating to the credit card are only kept during the processing time of the reservation.

The customer has the possibility of renouncing the rental of equipment, on condition of doing so eight clear days before the date provided by registered letter with acknowledgment of receipt to the store address. Failing to make known his intention to renounce the rental within the above period, the amount paid will not be returned.
